To: Morgan Lawson, a resident of said Blue Hill, in said County.

Greetings: In the name of the State of Maine, you are hereby required to warn and notify the voters of Blue Hill, in said County, qualified by law to vote in Town affairs, to meet in the auditorium at the Town Hall, Blue Hill, on Friday, April 4, 2024, at 9:30 am, then and there to act on the following articles to wit:

ARTICLE 1. To choose a moderator to preside at said meeting.

***NOTE:** Articles 2 through 5 are set out in a written ballot to be acted upon Friday, April 4. The polls will be open for voting in the auditorium at the Town Hall at 10:00 am and close at 8:00 pm. The meeting will reconvene Saturday, April 5, 2025, at the Blue Hill Consolidated School gymnasium at 9:00 am and will run until adjourned by the moderator.*

ARTICLE 2. Election of officers

ARTICLE 3. GSA Excess Charge

Shall the Town raise and appropriate \$164,900 from Property Tax in Excess Tuition Charges for George Stevens Academy (in excess of the maximum allowable tuition and Insured Value Factor payments set by the state) and authorize the School Committee to pay George Stevens Academy during the school fiscal year 2025-2026 an additional \$1,700 per student, for up to 97 students, the maximum number of Blue Hill students estimated to attend George Stevens Academy during the 2025-2026 school year? All such amounts appropriated will be additional local funds which exceed the state's Essential Programs and Services allocation model for this purpose.

ARTICLE 5. Carbon Fee and Dividend

Shall the town authorize the Select Board to convey to Blue Hill's state legislators, Members of Congress, Governor, and President of the United States that the town hereby calls upon our Federal elected representatives to enact carbon-pricing legislation to protect Maine from the costs and environmental risks of continued climate inaction?

To protect households, we support Cash-Back Carbon Pricing that charges fossil fuel producers for their carbon pollution and that rebates the money collected to all residents on an equal basis with monthly dividend checks.

If approved, the record of the vote regarding this article shall be transmitted by written notice to the above mentioned parties by the Select Board within 30 days.

ARTICLE 6. To authorize the moderator at their discretion, to dispense with the complete reading or re-reading of an article and allow the Town to vote by written ballot upon a request from 10 or more voters.

State-Mandated Explanation: The town's contribution to the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that a municipality must raise in order to receive the full amount of state dollars.

ORDINANCE ARTICLES

ARTICLE 66. Shall amendments to the ordinance entitled “Shoreland Zoning Ordinance for the Municipality of Blue Hill” be enacted?

ARTICLE 67. Shall an ordinance entitled “Blue Hill Healthy Ecosystem Ordinance 2025” be enacted?

Explanation: The new ordinance, whose adoption would repeal and replace the existing ordinance of similar title, is offered to fulfill a promise made at the Town Meeting in April 2024, by a group of Town voters, to provide alternate and more narrow language to improve upon the amendment that was passed at the 2024 Town meeting. The 2024 amendment was a blanket exemption for anyone to use prohibited pesticides in cases of invasive species. The replacement language offered in 2024 updates the ordinance, provides for a specific process to apply for a waiver for pest emergencies, and a specific exemption to authorize the Blue Hill Tree Warden to oversee pesticide treatments for Dutch Elm Disease, emerald ash borer, and browntail moth. A copy of the proposed amendments to the ordinance is attached to the posted warrant and copies are available at the Town Office and at <https://bluehillme.gov>.

OTHER ARTICLES

ARTICLE 68. To see if the Town will vote to authorize the Select Board to sell a town-owned right of way, located at 820 Ellsworth Road, Map 29 Lot 72, for such price and subject to such terms and conditions as the Select Board may deem appropriate.

ARTICLE 69. To see if the Town will authorize the Select Board, on a continuing basis until such authority is revoked by a vote of the Town, to accept easements on real property owned by others and benefitting the Town, subject to such terms and conditions as the Select Board may deem reasonable.

ARTICLE 70. To see if the Town will vote to (1) authorize the Tax Collector or Treasurer to accept prepaid taxes not yet committed, pursuant to 36 M.R.S. § 506; (2) fix the annual interest rate at 7.50% on overdue property taxes, tax liens, and tax acquired property; (3) set the date of October 15, 2025 for property tax payments after which interest will accrue on unpaid taxes; (4) authorize the Select Board to sell and repurchase lots in the Town's cemeteries and accept payments for said lots; and (5) authorize the expenditure of an amount not to exceed 4/12 of the amount assigned to each budget category of the 2025 Annual Budget during the period from January 1, 2026 to the 2026 Annual Town Meeting.


